Roll call: There are currently 13 filled seats on the Board of Directors. A quorum consists of 7 or more members in attendance. A **quorum is present** as 12 members are in attendance. A By-Law amendment requires a ¾ vote of the filled seats; 0.75 X 14 so 11 votes would be required to amend the By-Laws.

1. Call to Order

Gary Stroick called the meeting to order at 9:05pm Eastern Time. At that time, a quorum was confirmed. The newly elected Board members attended the meeting as non-voting guests.

Gary requested this emergency Board meeting to discuss the Memorandum of Understanding between USA Dance and USA Breakin.' This is the fourth Board meeting to discuss the integration of USA Dance and USA Breaking (see Board Minutes from November 2, November 23 and December 7) and USA Breakin' had requested a vote by USA Dance on the MOU.

On December 7, the International Olympic Committee announced the inclusion of Breakin' in the 2024 Olympiad. Following the Board meeting on December 7, Gary recirculated material to Board members describing criteria for certification as a US Olympic and Paralympic National Governing Body and listing which steps USA Dance had accomplished. On December 9, 2020, there was a request by USA Breakin' to conduct an email vote on the MOU. The Board preferred an additional meeting and discussion prior to a vote on the MOU.

Gary asked Michael to lead the meeting in response to a request from Clifford. The MOU was discussed at length. Key points of discussion were whether the MOU should be approved at this time and whether USA Breakin' was properly positioned to be a partner with USA Dance.

Following discussion, Roger brought a motion to approve the MOU. Michael asked to amend the motion to add a clause to permitting termination for cause if a breach is not cured within 30 days in response to a request by Damian during the discussion - a standard contract clause with legal language to be supplied by Sheppard Mullin or the Legal Affairs Committee. Roger accepted the amendment.

Greg brought a motion to table the voting to approve the agreement until the next Board meeting.
